

Dangerous Goods

are prohibited to be sent through air transportation

EXPLOSIVES



Examples of explosives include firearms, fireworks and bombs

GASES



Examples of gases include butane lighter, butane gas and medical oxygen, aerosols

FLAMMABLE LIQUIDS



Examples of flammable liquids include paints, petrol, thinner, alcohols and perfumery products

FLAMMABLE SOLIDS



Examples of flammable solids include matches, lighters and sulphur

OXIDIZING SUBSTANCES AND ORGANIC PEROXIDE



Examples oxidising substances and organic peroxide include bleach, peroxide, fibre glass and repair kits

TOXIC AND INFECTIOUS SUBSTANCES



Examples of toxic and infectious substances include poison, virus cultures and pathology specimens

RADIOACTIVE MATERIALS



Examples of radioactive materials include domestic smoke detector and x-ray

CORROSIVE MATERIALS



Examples of corrosive materials include batteries, acids, mercury, alkaline and caustic soda

MISCELLANEOUS DANGEROUS GOODS



Include magnetized materials such as equipment containing lithium batteries, asbestos, dry ice and other potentially hazardous materials

IMPORTANT NOTES:

Please note that you are required to declare the contents of your parcels in a complete, accurate and correct manner to our counter staff for acceptance. Posting of any Dangerous Goods as defined by the International Air Transport Association (IATA), International Civil Aviation Organization (ICAO) and Civil Aviation Act 1969 (Act 3) under the Dangerous Goods Regulations (DGR) which includes any amendments, updates or supplements that may be issued from time to time are totally prohibited. Pos Malaysia reserves its right to take necessary actions to, including but not limited to, dispose of or destroy or detain such item as permitted under the laws or directed by the relevant authority.

Pos Malaysia will not allow posting of such items at any time and reserves the right to refuse posting of such items that are prohibited by laws at any time or at its sole and absolute discretion if Pos Malaysia considers that such items could pose a risk to health, safety, property or the environment in any manner whether or not such items have been accepted for posting. In such event, Pos Malaysia will not refund the postage costs.

Pos Malaysia will not be liable for any claims in damages or delay of shipment if the item is deferred, detained, withheld, returned to sender, or was not processes because it contains or consist of aforementioned articles.

BAHAN LETUPAN



Contoh bahan letupan termasuk senjata api, mercun atau bunga api dan bom

GAS



Contoh gas termasuk pemetik api butana, gas butana, oksigen perubatan, aerosol

CECAIR MUDAH TERBAKAR



Contoh cecair mudah terbakar termasuk cat, petrol, pencair, alkohol dan produk minyak wangi

PEPEJAL MUDAH TERBAKAR



Contoh pepejal mudah terbakar termasuk mancis, pemetik api dan sulfur

BAHAN MENGOKSIDA DAN PEROKSIDA ORGANIK



Contoh bahan mengoksidasi dan peroksida organik termasuk peluntur, peroksida, kaca gentian dan peralatan membaiki

BAHAN TOKSIK DAN MUDAH BERJANGKIT



Contoh bahan toksik dan mudah berjangkit termasuk racun, kultur virus dan spesimen patologi

BAHAN RADIOAKTIF



Contoh bahan radioaktif termasuk peranti pengesan kebakaran domestik dan x-ray

BAHAN KAKIS



Contoh bahan kakis termasuk bateri, asid, raksa, alkali dan soda kaustik

LAIN-LAIN BAHAN BERBAHAYA



Termasuk bahan magnetik seperti barang yang mengandungi bateri lithium, asbestos, ais kering dan lain-lain bahan yang membahayakan

NOTA PENTING:

Sila isytiharkan isi kandungan anda dengan telus kepada kakitangan/petugas kaunter penerimaan kami. Pengeposan barangan berbahaya seperti yang tertakluk di dalam Peraturan Barang Berbahaya yang ditakrifkan oleh Persatuan Pengangkutan Udara Antarabangsa (IATA), Pertubuhan Penerbangan Awam Antarabangsa (ICAO) dan Akta Penerbangan Awam 1969 (Akta 3) termasuk pindaan, perubahan atau penambahan yang akan dimaklum dari semasa ke semasa adalah dilarang sama sekali. Pos Malaysia akan mengambil tindakan sewajarnya, termasuk tetapi tidak terhad kepada, melupuskan, menghapuskan atau menahan bungkusan terbabit.

Pos Malaysia tidak membenarkan pengeposan barangan terbabit dan berbahru untuk menolak pengeposan barangan lain yang dilarang oleh undang-undang atau pada pendapat kami boleh mendatangkan bahaya secara langsung atau tidak kepada kesihatan, keselamatan, harta benda atau alam sekitar. Sekiranya didapati terdapat barang larangan atau barangan berbahaya, bungkusan tersebut tidak akan dihantar dan kos pengeposan tidak akan dikembalikan.

Pos Malaysia tidak akan bertanggungjawab atas tuntutan kelewatan sekiranya item ditangguhkan, ditahan, dipulangkan kepada pengirim, atau tidak diproses kepada penerima kerana mengandungi isi kandungan yang tertera di atas.
